

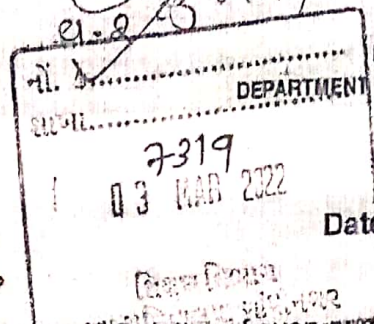

The Mission lays emphasis on functionality of tap connections on a long-term basis and arrangements for its regular operations and maintenance. For this, emphasis is being laid on regular water quality monitoring and surveillance at the school level by using "Field Testing Kits (FTKs)", as well as using Chemistry labs of higher secondary schools for water quality testing.

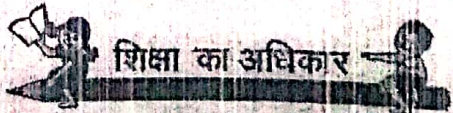
