NO.GH/SH/42/BMS/1115/1295/G:- In exercise of the powers conferred by section 15 of the Gujarat Secondary and Higher Secondary Education Act, 1972 (Guj.18 of 1973), the Government of Gujarat hereby makes the following rules further to amend the Principal in the Registered Private Secondary and Higher Secondary Schools (Procedure for Selection) Rules, 2017, namely:-

1. These rules may be called the Principal in the Registered Private Secondary and Higher Secondary Schools (Procedure for Selection) (Amendment) Rules, 2022.
2. In the Principal in the Registered Private Secondary and Higher Secondary Schools (Procedure for Selection) Rules, 2017, in rule 10, in sub-rule (1) to clause (b), the following proviso shall be inserted, namely:-

"Provided that the HMAT certificate issued prior to the five years from the date of publication of the Principal in the Registered Private Secondary and Higher Secondary Schools (Procedure for Selection) (Amendment) Rules, 2022 shall remain valid for appointment up to the 31st August, 2023."


