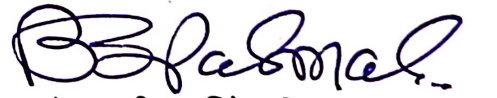

List again on 16.10.2025."

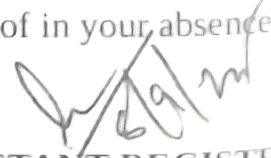
